Excursion - advice	
What to wear:	Must wear swimwear under their clothing when students arrive, t-shirt or rash vest (no sleeveless tops), board shorts or tights and a sun safe hat. Joggers are to be worn (these will get wet and dirty)
Food:	Bring your own recess, lunch, and water bottle in your school bag
What not to bring:	Mobile phones, iPods, electronic games, or lollies
Rules:	 Wearing of a hat is compulsory Sun Safe Policy states that children must have sunscreen with them for this excursion Students are reminded to reapply 30+ (or higher), broad-spectrum, and water-resistant sunscreen before outdoor activities
Attending Teachers:	Shellharbour Public School teachers Illawarra Environmental Education staff Two certified paddling instructors will be in attendance.

Travel will be by bus with Kiama Coaches. All seats will have a seat belt. Students over 12 will need to wear a face mask on NSW Public Transport. These will be provided by the school.

All Shellharbour Public School staff attending hold current emergency care and CPR certification.
